Re-Sort Software License Agreement

Google Marketplace VM License

By purchasing or executing the AHLSORT SOFTWARE as a Re-Sort Virtual Machine Image through the Google Cloud Marketplace, you agree to be bound by the terms of this Agreement. If you do not agree to the terms of this Agreement, promptly delete the Re-Sort virtual machine.

Re-Sort Software License

1. **GRANT OF LICENSE.** This Software License Agreement (“License”) permits you to use the specified version of the Software product identified above, which may include user documentation provided in “online” or electronic form (“SOFTWARE”), on Virtual Machines (VMs) procured through the Google Cloud Marketplace as Touchwood Re-Sort Virtual Machines.
2. **LICENSE TYPE.** In event that the license is for a Single-Machine, a Single-Machine is defined as a single physical or virtual machine with a specified number of processor cores or vCPUs. Virtual machines are considered to be the same as physical machines and must be individually licensed.
3. **COPYRIGHT.** The SOFTWARE (including any images, “applets,” photographs, animations, video, audio, music, messages, documentation, and text incorporated into the SOFTWARE) is owned by us and is protected by United States copyright laws and international treaty provisions. Therefore, you must treat the SOFTWARE like any other copyrighted material (e.g., a book or musical recording).
4. **OTHER RESTRICTIONS.** You may not rent, lease, transfer, donate, distribute or sell the SOFTWARE or the **LICENSE KEY FILE**. You may not reverse engineer, decompile, or disassemble the SOFTWARE, except to the extent that the foregoing restriction is expressly prohibited by applicable law. Possession of the software and/or the **LICENSE KEY FILE** does not constitute a license to use the software.

TERM. This license is for a one (1) day term. This Agreement shall automatically renew on each subsequent day unless it is terminated by either party. At the end of the license term, the software may no longer be used and should be removed from all systems and backups.
